Peter is also an expert for the Belgian National Standardisation Body (NBN) for everything that has to do with ISO 31000 (1262).

ABOUT GNIC®

GNIC® is an initiative of an international group of individuals, independent from any interest or pressure group, concerned with the development and usage of high quality, effective and efficient certification services for individuals and legal entities. They operate under the legal entity of a Not For Profit Organisation, according to Belgian Law, named "Global Network for Independent Certification", abbreviated «GNIC». GNIC® is the registered brand name.

GLOBAL: Global stands for the variety of international experts that are at the core of the Global Network for Independent Certification. It also refers to the ambition of having an international and world-wide reach for its services.

NETWORK: GNIC[®] is a network organisation of independent professionals or their corresponding legal entities.
