ABOUT THE TRAINER



Peter Blokland studied at the Royal Military Academy in Brussels obtaining his MSc degree in Military and Aeronautical sciences (1983), to start a career as a fighter pilot, flying the F-16 at Kleine Brogel airbase (1985). He continued his career as a flight instructor, educating students to become pilots. He also occupied duties as a staff officer, commanding officer and aircraft accident investigator, following various courses regarding aviation safety, human factors and aircraft accident investigation. He finished his military career at the NATO HQ, SHAPE, NucOps, dealing with the surety and command & control of NATO's special weapons.

At the age limit, he retired from military service in 2007 to start a second career as a **business coach, trainer and consultant, specialised in ISO 31000, Systems Thinking and Organisational Alignment**. In 2013, together with Prof.dr.ir. Genserik Reniers, he wrote the book "Total Respect Management" (in Dutch), later followed by the book "Safety & Performance" (2017, in English).

This was followed by completing a PhD study at TUDelft resulting in a thesis titled "**Towards sustainable safety and performance in organisations**" (March 2023).

Peter is also a member of the **Belgian I262**, supporting NBN and ISO TC262 (ISO 31000) with his experience.

CERTIFICATION EXAM

This certification is **independent from the course** and provided online by GNIC®. The **CRMF® certification**, obtained via an online exam using the **testinvite** platform, gives you the title:

“Professional Certified in Risk Management in accordance with ISO 31000 - Foundations Level”

Regarding the use of the exam software:

Please use Chrome, Firefox or Opera as a browser to complete your exam. Other browsers, such as Safari, can cause problems.

The exam is a "closed book" exam. The system will monitor the execution. Therefore, it will use your camera and microphone to monitor you during the exam and the software will only allow for a "full screen" mode. Please make sure the safety settings on your device allow for such practice.

How it works:

When you click the start button, the system asks for permission for **webcam monitoring and full screen mode**. Your browser and computer settings for webcam recording and screen sharing should be activated. This guide explains how to activate full-screen mode for candidates to start an exam. **Please check it in due time to avoid problems during the certification exam.**

ABOUT GNIC®

GNIC® is an initiative of **an international group of individuals**, independent from any interest or pressure group, concerned with the development and usage of high quality, effective and efficient certification services for individuals and legal entities. They operate under the legal entity of a **Not For Profit** Organisation, according to Belgian Law, named “Global Network for Independent Certification”, abbreviated «GNIC». **GNIC® is the registered brand name.**

GLOBAL

Global stands for the variety of international experts that are at the core of the Global Network for Independent Certification. It also refers to the ambition of having an international and world-wide reach for its services.

NETWORK

GNIC® is a network organisation of independent professionals or their corresponding legal entities. While a small dedicated crew provides for logistic and administrative support, anyone wishing to become part of the network can do so, at least when the values and guiding ethical principles of this network are endorsed.

INDEPENDENT

Independent also means that any individual or legal entity can apply for GNIC® certification, independent from the preparation or education this individual or legal entity has adopted or practiced.
